WAIVER OF THE PRE-EXISTING MEDICAL CONDITION EXCLUSION

 b. You are medically able and not disabled from travel at the time Your plan cost is paid based on assessment of a Physician.

Trip Cancellation / Trip Interruption: If you cancel your trip for a covered reason prior to the scheduled departure date, we can reimburse up to the maximum benefit amount shown in the schedule of benefits, for the unused, forfeited, prepaid non-refundable payments or deposits for travel arrangements you purchased for your trip. // If you must start your trip late or are unable to complete your trip due to a covered reason, we can reimburse up to the maximum benefit amount shown in the schedule of benefits for unused non-refundable land or water travel arrangements plus the additional transportation cost paid to: a) join your trip if you must depart after your scheduled departure date or travel via alternate travel arrangements; or b) rejoin your trip from the point where you interrupted your trip to the next scheduled destination; or c) transport you to your originally scheduled return destination of your trip.

Trip Delay: Reimburses up to the maximum benefit amount shown in the schedule of benefits, for the unused, forfeited, prepaid non-refundable payments or deposits for the travel arrangements, reasonable additional expenses, plus the additional transportation cost paid to join/re-join your trip or be transported back to your final destination if your trip is delayed at least 6 consecutive hours from the original departure time and this prevents you from reaching your scheduled destination.

Missed Connection: Provides coverage when you miss your trip departure because your arrival at your trip destination is delayed for at least 3 consecutive hours due to any delay of a Common Carrier; documented inclement weather; or quarantine, hijacking, strike, natural disaster, terrorism or civil disorder or riot.

Medical Evacuation and Repatriation of Remains: Among other things, this reimburses transportation expenses incurred to transport you to the nearest medical facility where treatment is available if you incur a sickness or injury that is acute or life-threatening during your trip and adequate treatment is not available in your immediate area.

Political or Security Evacuation and Natural Disaster Evacuation: Coverage for reasonable expenses incurred for your transportation to the nearest place of safety or to your host country when you must leave your trip for a covered political, security or natural disaster event while traveling outside your home country.

Baggage and Personal Effects: Reimburses you if your baggage & personal effects are lost, stolen, damaged or destroyed during your trip or while checked with a common carrier.

Baggage Delay: Provides coverage if your checked baggage is delayed or misdirected by a Common Carrier for at least 12 hours from your time of arrival at a scheduled destination other than your return destination.

Accident & Sickness Medical Expense: Provides coverage if a covered accidental injury or sickness occurs during your trip.

Optional Cancel for Any Reason(CFAR): If you cancel your trip for any reason not otherwise covered by this plan, benefits may be reimbursed for up to 75% of the trip cost provided your payment/deposit for this plan is received within the time sensitive period, and you must cancel the trip 48 hours or more before scheduled departure date of your trip. Additional costs and terms apply.
